1610/4 Minutes of Previous Meeting

1610/7 CCTV

Council considered a report from Danny Harsley, Senior Engineer from Vidicom Ltd, the company responsible for the maintenance of the towns CCTV equipment. In addition to the report, Mr. Harsley advised flooding the park with signage relating to the CCTV equipment, cutting the tree's back/down at both ends of the park and lowering the wall at the entrance to the park from West Street, with the aim to reduce to anti-social behavior in the park.

Resolution: The Council considered the report and agreed with Mr. Harsleys additional recommendations. The Council agreed to install additional signage in the park, take further advice on what action could be taken with the trees and look into lowering the wall and installing railings, at the entrance to the park.

1610/9 Neighbourhood Plan

Cllrs P. Mumby, P. McCartan and P. Coath met recently to discuss the Neighbourhood Plan and had asked the Clerk to look into whether or not the Plans were still seen as a worthwhile project. Cllr P. Mumby proposed that the Neighbourhood Plan working group should look to move the project on and work towards completing a Plan.
