Minutes of the Meeting of Winterton Town Council held on Tuesday 15th November, 2016 at 7.30pm in the Old School Hall, West Street, Winterton.

Public Participation:

The following matters were raised by/on behalf of members of the public:

- 1. Mr. Booker informed the Council that there are a number of options, when it comes to pensions and it is vital elderly people are made aware of what they are entitled to. Fortunately, this area is one of the best areas for getting the information out there.
- 2. A resident wished to raise the issue of the Roxby Trods. The path is in such a mess; people with a pushchair or using a mobility scooter are unable to use the path. The path is very well used by people coming to shop/school or work in Winterton. The resident has been reported the issue to NLC but the matter hasn't been followed up by them. The grass requires cutting back to return the path to its full width and the mud needs clearing. There is evidence of vehicles being driven up there.

Cllr D. Johnson informed the meeting, he and the clerk had visited the trods that morning and they were indeed a terrible mess.

Cllr R.Ogg offered to take up this matter with the relevant officer at NLC.

Cllr D. Johnson suggested writing to Mr. Tim Allen at NLC to resolve this matter and get the Trods back to a useable state.

1611/6 West Street Park Boundary Fence

The Council considered a request from Birtwhistle Landscaping Limited on behalf of Keigar Homes to erect a fence (to match the existing) in place of the conifer trees along the boundary of West Street Park and the Keigar Development on West Street.

The Council considered suspension of the meeting to hear information from Mr. Jonathan Birtwhistle, Birtwhistle Landscaping.

Resolution: That the meeting be suspended.

Mr. Birtwhistle gave details of the proposal put forward from Keigar Homes to remove the conifer trees on land owned by Keigar but also to remove the conifer trees on land owned by the Town Council. A fence would be erected to replace the trees, identical to fence already in situ along parts of the boundary.

The council discussed the matter and felt that not enough information had been made available to them in order to make an informed decision.

Resolution: The Property Committee to meet prior to the December Full council meeting to discuss the proposal in more detail and put forward recommendation to Council.

1611/7 Report from Ward / North Lincs. Councillors

1611/8 Police Matters

a.Cllr J. Ramseyer reported on the NATs meeting held on Wednesday 9th November. PC Amanda Barnett had attended the meeting and said that she felt the issues with young people and anti-social behavior was no different than it was 7/8 years ago. Residents are not using 101 to reported incidents of anti-social behavior and as a result they are not logged in the system and the local team is unaware of the issues. Five individuals were identified as been involved in anti-social behaviour and were served a 48 hr. dispersal order under section 35, from West Street Park. Extra patrols have been agreed in the run up in to Christmas

The next NATs meeting is on the 18th January 2017, at Sir John Mason House, Winterton.

The meeting was suspended due to youths entering the building and throwing wet toilet roll at the internal doors.

The meeting was re-convened.

Cllr J. Ramseyer reported that PC Barnett had said the police had not received calls for service for incidents relating to the Earlsgate/Stovin Crescent snickett.

Cllr I. Cawsey reported that he had visited a resident in the area who was subject to a number of anti-social incidents.

The meeting was suspended due to youths throwing wet toilet roll at the windows.

Whilst the meeting was suspended, Cllr R.Ogg reported that he was following up the suggestion for NLC to install railing along the side of the property adjacent to the Earlsgate/Stovin Crescent snickett, as discussed during the walkabout. The new residents were looking to clear the bushes and install a fence.

The meeting was re-convened.

b. The Council agreed the need to promote 101 and encourage resident to use it to report incidents of anti-social behavior.

1611/9 Winter Snow Provision

Cllr D. Johnson reported that all grit bins were now out and we are waiting a delivery of grit from NLC. NLC have agreed to fill the Town Council's green grit but not the bins supplied by WCCG. These are to be filled by WCCG and the Town Council. The Council needs to appoint a new snow warden since the resignation of Cllr M. Buckley.

The meeting was suspended due to youths throwing rolled up wet toilet paper at the windows.

The meeting was re-convened.

No-one came forward as snow warden; therefore Cllr P. McCartan will speak to members of the WCCG at their next meeting for a possible solution.

1611/10 Christmas Events

The Clerk reported that the Christmas tree would be delivered on Friday 18th November. We had to change suppliers this year as the previous supply was no longer selling large trees. Lighting installation is starting this week, weather permitting. The Clerk gave a brief overview of the light switch on event to be held on Friday 2nd December and the Carols around the tree event to be held on Christmas Eve. Formal road closures, as well as Temporary Events notices had been applied for, for both events. b. No further action required.

1611/11 <u>Year of Youth</u>

Cllr P. McCartan reported that he was waiting to hear from the Academy, for a date, for a meeting to discuss the Youth Town Council. Representatives from each year will meet on a regular basis to discuss issues that affect them, and Cllr P. McCartan hoped to get things started with a survey to find out what young people think of Winterton and what can be done to improve it.

Cllr I. Cawsey said it was important that all young people of Winterton had a voice not just those attending the Academy.

Cllr P. McCartan agreed and said working with the Academy was just the start and hoped the project would involve all children who live in Winterton.

1611/12 Winterton 2022

Cllr J. Ramseyer reported that W2022 had awarded £1000 to the Grangefield Committee to get them started on projects and they would continue to support the work of this group.

Cllr P. McCartan asked if Chris Ellerby, from W2022 was based in Winterton and if not, the Council Office could be made available to him, to allow residents to drop in, to speak to Mr Ellerby regarding W2022 projects.

Cllr J. Ramseyer said he would pass the comments onto the group.

1611/13 Winterton Community Pavilion

The Clerk reported that the hall had been busy with children's parties. Sleeping Dragon Kickboxing has done some more advertising and has seen an increase in numbers; as a result they have booked the pavilion on a Tuesday evening, on a casual basis. A company based at the shopping village, specialising in Wedding decorations, decorated one half the pavilion to show what the room could like for a wedding. The emergency lighting has been checked and 3 lights require new batteries, we are waiting on a quote for these. We have purchased new pads for the buffer machine and they have made a huge difference to the floor. We are in the process of drawing up a maintenance list that we will address over winter.

Cllr L. Langton asked Councillors if they had any raffle prizes they would be happy to donate for the raffle on the 2nd December. All monies raised are to go to the Pavilion for equipment.
