The residents attending all spoke in objection to Planning Application PA/2023/1026. Residents asked why they hadn't been notified.

Residents were advised of the planning process and of the importance of adding their comments directly to the planning officer and on the planning portal. They were advised to comment solely using valid planning considerations and were provided with examples.

**Comment** - Winterton Town Council strongly objects to this application.

Leys Lane is a single track road, that is in a constant poor state of repair. It is wholly unsuitable for the extra traffic this application will bring.

The two roads that Leys Lane truncates are busy, fast flowing roads. making it unsuitable for extra vehicle to access and exit.

The land is agricultural land and as such unsuitable for residential dwellings.

The negative impact on the environment is unacceptable as this is a site where wild animals and

I ne negative impact on the environment is unacceptable as this is a site where wild animals and birds have safe haven.

Winterton has already expanded exponentially recently with 4 large developments being permitted and it must be questioned as to whether the health and education providers can cope with the demands a site such as this will bring.

There is scant/no information provided on the sustainable drainage system for foul and surface water. Winterton's drainage is a combined one and the recent permitted developments have already had a negative impact on the drainage in the town. Winterton Town Council can not understand how the LLFA has not requested further information.
