#### 2023/062 NLC Ward Councillors report. - Cllr Marper presented the following.

- 7000 free swims over the summer holidays.
- Fuelled activities over the summer, unfortunately low take up.
- Government approval to impose £1000 fines for fly tipping. Zero tolerance approach. Often evidence is present to make prosecutions easier.
- Random checks with a possibility of fine of £100 if dog walker is found with no poop bags.
- Litter and dropping cigarette end fines can be imposed of up to £200.
- Pleased to report no school is found with RAAC concrete in North Lincolnshire.
- Planning permission granted for the new health and diagnostic centre in Scunthorpe. Next to Multi Storey Car Park with 2 hours free parking and the bus station making accessibility easier than the hospital. Its hoped that 150,000 x-ray, radiology and scanning appointments will take place per year
- NLC has a cross-party joint motion for Full Council in October stressing that moving paediatrics out of Scunthorpe will not be acceptable. Maternity and A&E are not moving. Specialist and Critical Care needing more than 72 hours stay in hospital is being proposed.
- The Queen Elizabeth memorial garden opened in Scunthorpe Church Square. One of the first to be approved in the country bearing the late Queen's name.
- More Govt. money made available for low-income households to insulate their homes to make more energy efficient.

Winterton Gym, Library and Skate Park

Meeting with officers has taken place and we are looking at various solutions and will be carrying out a consultation with residents in near future.

Round Four of PCC Community Safety Fund is now open for applications, perhaps the Bike Park would be a good contender.
