(i) **PA/2024/766** Application to modify/discharge the S106 Agreement attached to PA/2019/1414 relating to the request for contributions be removed for viability reasons, Land to the rear of 99 North Street, Winterton, DN15 9QW.

Comments Whilst WTC is extremely disappointed that the developer is wanting to remove the conditions imposed by the planning inspector reference \$106 contributions towards the artificial pitch on Newport Drive, the 13 affordable dwellings and the contribution towards education in the town, Winterton Town Council reluctantly agrees to support taking responsibility of the green open space within the development and accept the \$106 contribution of £80316.00 for devolved maintenance. It also proposes a further condition that the developer does not build a new play area within the development but invests in the green open spaces, maintained by Winterton Town Council already in the town and proposes that another £25,000 is contributed via \$106 money to improve the already existing recreational facilities in the town.
